

## **How to complete the administrative forms (Part A: Forms A1 – A2).**

### **1. Proposal Full Name**

Use a clear, self explanatory title of not more than 20 words, providing guidance as to the contents of the Exploratory Award.

### **2. Proposal Acronym**

Provide a short title or acronym of no more than 20 characters, to be used to identify the Exploratory Award. The same acronym should appear on each page of the Exploratory Award in order to prevent errors during its handling.

### **3. Thematic Priorities of the Research Programmes**

The thematic priorities addressed by your Exploratory Award as indicated in this list. The list is organised so that the first three digits indicate the programme (in bold) and the last digit(s) indicate(s) the thematic priorities. If more than one thematic priority is addressed, indicate them in priority order, so that the main priority addressed by the Exploratory Award is mentioned first. For Exploratory Awards preparing a CRAFT Step 2 proposal, indicating the thematic priorities is recommended, but not mandatory.

The page A1 “Exploratory Award (Step 1) - Administrative Overview” is to be completed by the SME Co-ordinator submitting the Exploratory Award on behalf of the consortium.

#### **5. SME Co-ordinator Organisation Legal Name**

You must use the complete legal name of the organisation which acts as SME Co-ordinator. Use the same legal name as in form A2. The SME Co-ordinator acts as a contact on behalf of the consortium after the evaluation of the Exploratory Award. Payment of the Exploratory Award is made to the SME Co-ordinator.

#### **6. Proposal Abstract**

The proposal abstract should be a very short and precise presentation of the main features (scientific and technological) of the proposal. Why is it proposed and what problem is it solving? What are the objectives? How will the objectives be achieved? What results are expected? This proposal abstract will be used in the evaluation process and in communications about the proposals to the interested parties (Commission services and programme committees etc.). Please use plain typed text, avoiding formulae and other special characters. If the Exploratory Award is written in a language other than English, please include in form A1 an English version of the abstract.

#### **7. Project Duration**

Duration of the Exploratory Award in months. Maximum 12 months.

#### **8. Total estimated Eligible Cost**

Please indicate the total estimated eligible cost of the Exploratory Award (in euro). Maximum EUR 30 000. These eligible costs should mainly consist of :

- personnel costs,
- subcontracting,
- travel and subsistence,
- computing,
- overhead costs.

#### **9. EC Contribution requested**

The total contribution requested for the Exploratory Award project from the European Community in euro. This EC contribution is 75% of the total exploratory costs, up to a maximum of EUR 22 500.

#### **10. Type of Step 2 project envisaged**

Please indicate the type of project which you intend to prepare with your Exploratory Award. More information on the possible types of projects is available on the cover of this information brochure.

#### **11. Business areas (NACE)**

Use the appropriate code(s) for the principal economic activities as indicated in the NACE Rev. 1 classification as defined in the annex “NACE codes for business activities” (NACE is “Nomenclature générale des activités économiques dans les Communautés européennes”). The principal economic activity of the organisation is the activity that contributes most to the gross value added at factor cost.

## 31. Affiliation

Company A controls company B if:

- A has, directly or indirectly, the decision-making powers within company B.

It should be noted that Company A's holding a simple majority of the share capital, or the voting rights, of Company B may be sufficient to create a controlling relationship.
